NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the property control division of the general services department be requested to explore purchase of the public employees retirement association and national education association buildings, two residences on Don Gasper in the area of the central capital complex and the unoccupied facilities at Budagers on interstate 25 between Santa Fe and Al buquerque; and

BE IT FURTHER RESOLVED that the property control division report its progress to the capitol buildings planning commission; and

BE IT FURTHER RESOLVED that a copy of this memorial be transmitted to the property control division of the general services department and the capitol buildings planning commission.
