STATE OF NEW MEXICO that the department of health, with the cooperation of the commission for deaf and hard-of-hearing persons, develop a factual assessment of the current newborn hearing screening practices throughout New Mexico; and

BE IT FURTHER RESOLVED that in so doing, statewide hospital representatives, medical practitioners, audiologists, early intervention specialists, members of the deaf and hardof-hearing community and other health consumers and the health insurance industry be consulted; and

BE IT FURTHER RESOLVED that the financial impact of requiring newborn hearing testing, including available funding resources, be assessed; and

BE IT FURTHER RESOLVED that practices and statutes of other states be taken into consideration; and

BE IT FURTHER RESOLVED that the results of this assessment, together with any recommendations for legislation, be presented to the governor and to the legislative health and human services committee by September 1, 1999; and

BE IT FURTHER RESOLVED that copies of this memorial be delivered to the department of health and the commission for deaf and hard-of-hearing persons.
