and

WHEREAS, New Mexicans living in rural areas face unique
obstacles in obtaining services that are taken for granted by
their urban counterparts, including access to health care, a
ready availability of job and educational opportunities and
economies of scale in public services and infrastructure; and

WHEREAS, the revitalization and preservation of rural New
Mexico is important to all of New Mexico;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
STATE OF NEW MEXICO that the New Mexico legislative council be
