10 A CONCURRENT RESOLUTION

11 AMENDING LEGISLATIVE JOINT RULE 3-1 PERTAINING TO CONFERENCE
12 COMMITTEES.
13

14 WHEREAS, Legislative Joint Rule 8-1 requires that joint
15 rules may be adopted, amended or repealed by concurrent
16 resolution approved by two-thirds of the membership of each
17 house;

18 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
19 REPRESENTATIVES, THE SENATE CONCURRING THEREIN, that the
20 following joint rule be amended as follows:

21 "CONFERENCE COMMITTEES (3-1)

22 If one house refuses to concur in the
23 amendments made to its bill by the other house, the
24 chief clerk shall notify the house making the
25 amendments of that refusal to concur and ask that

1 it recede from its amendments. If the amending
2 house refuses to recede from its amendments, a
3 conference committee, consisting of three members
4 from each house, shall be appointed by the
5 president pro tempore of the senate and the speaker
6 of the house. The conference committee may meet
7 only after reasonable notice of the meeting has
8 been provided to the public by both houses.
9 Conference committee meetings shall be open to the
10 public; provided that conference committee meetings
11 may be closed to the public during committee
12 discussions of personnel issues or issues related
13 to pending litigation. The conference committee
14 shall meet at a time to be mutually agreed upon by
15 the committee members, and when agreement on the
16 amendments in dispute has been reached, the members
17 shall report to their respective houses, or if
18 agreement has not been reached, they shall report
19 that fact to their respective houses. No new item
20 shall be presented as an amendment for inclusion in
21 the conference committee report unless the item has
22 been the subject of a legislative committee hearing
23 during the session. Voting in the conference
24 committee shall be by the respective houses, and a
25 majority of the membership from each house is

1 required for adoption of a recommendation. The
2 report of the conference committee shall not be
3 subject to amendment in either house. The report
4 of the conference committee shall always be in
5 order except during a roll call or when a question
6 of order or a motion to adjourn is pending."
