11 PROPOSING TO AMEND ARTICLE 5, SECTION 14 OF THE CONSTITUTION
12 OF NEW MEXICO TO CHANGE THE NAME OF THE STATE HIGHWAY
13 COMMISSION TO THE STATE TRANSPORTATION COMMISSION.

15 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 Section 1. It is proposed to amend Article 5, Section 14
17 of the constitution of New Mexico to read:

18 "There is created a "state [~~highway~~] transportation
19 commission". The members of the state [~~highway~~]
20 transportation commission shall be appointed, shall have such
21 power and shall perform such duties as may be provided by law.
22 Notwithstanding the provisions of Article 5, Section 5 of the
23 constitution of New Mexico, state [~~highway~~] transportation
24 commissioners shall only be removed as provided by law. "
