15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 10-11-2 NMSA 1978 (being Laws 1987,
17	Chapter 253, Section 2, as amended) is amended to read:
18	"10-11-2. DEFINITIONSAs used in the Public Employees
19	Retirement Act:
20	A. "accumulated member contributions" means the
21	amounts deducted from the salary of a member and credited to
22	the member's individual account, together with interest, if
23	any, credited to that account;
24	B. "affiliated public employer" means the state and
25	any public employer affiliated with the association as provided

in the Public Employees Retirement Act, but does not include an employer pursuant to the Magistrate Retirement Act, the Judicial Retirement Act or the Educational Retirement Act;

4 C. "association" means the public employees
5 retirement association established under the Public Employees

D. "disability retired member" means a retired member who is receiving a pension pursuant to the disability retirement provisions of the Public Employees Retirement Act;

E. "disability retirement pension" means the pension paid pursuant to the disability retirement provisions of the Public Employees Retirement Act;

F. "educational retirement system" means that retirement system provided for in the Educational Retirement Act;

G. "employee" means any employee of an affiliated public employer;

H. "federal social security program" means that program or those programs created and administered pursuant to the act of congress approved August 14, 1935, Chapter 531, 49 Stat. 620, as that act may be amended;

I. "final average salary" means the final average salary calculated in accordance with the provisions of the applicable coverage plan;

J. "form of payment" means the applicable form of .215850.1GLG

11 person who has been but is not currently employed by an
12 affiliated public employer, who has not retired and who has not

(1) "adult correctional officer member" means a member who is employed as an adult correctional officer or an adult correctional officer specialist by a state correctional facility of the corrections department or its successor agency;

(2) "juvenile correctional officer member" means a member who is employed as a juvenile correctional officer by the children, youth and families department or its successor agency;

(3) "municipal detention officer member" means a member who is employed by an affiliated public employer other than the state and who has inmate custodial responsibilities at .215850.1GLG

requirements for retirement and who is receiving a pension from the fund;

T. "retirement board" means the retirement board provided for in the Public Employees Retirement Act;

"salary" means the base salary or wages paid a 5 U. member, including longevity pay, for personal services rendered 6 7 an affiliated public employer. "Salary" shall not include overtime pay, unless the overtime payment is required for a 8 regular scheduled tour of duty as set forth in Section 207(k) 9 of Title 29 of the United States Code and is made on the 10 regular payroll for the period represented by that payment, 11 12 allowances for housing, clothing, equipment or travel, payments for unused sick leave, unless the unused sick leave payment is 13 made through continuation of the member on the regular payroll 14 for the period represented by that payment, and any other form 15 of remuneration not specifically designated by law as included 16 in salary for Public Employees Retirement Act purposes. 17 Salary in excess of the limitations set forth in Section 401(a)(17) of 18 the Internal Revenue Code of 1986, as amended, shall be 19 20 disregarded. The limitation on compensation for eligible employees shall not be less than the amount that was allowed to 21 be taken into account under the state retirement system acts in 22 effect on July 1, 1993. For purposes of this subsection, 23 "eligible employee" means an individual who was a member of a 24 state system before the first plan year beginning after 25
